RECALL OF SCOTT VANISH EVO BICYCLE HELMETS MODEL YEAR 2015

February 2015

Dear Partners

We are writing to inform you about a recall on SCOTT Vanish Evo bicycle helmets of model year 2015.

In cooperation with the US Consumer Product Safety Commission (CPSC), SCOTT USA Inc. is voluntarily recalling all Vanish Evo bicycle helmets of model year 2015. These bicycle helmets fail impact testing required under CPSC's Safety Standard for Bicycle Helmets. Riders wearing these helmets are not properly protected from falls, and could suffer severe head injuries.

This recall involves model year 2015 SCOTT Vanish Evo bicycle helmets. The helmets have the brand name "SCOTT" and the model name "Vanish Evo" on the inside of the helmet. They were sold in black/grey and white/grey. The following serial number ranges are included in the recall: **2014-06/009359** to **2014-09/027210**.

The serial number is printed on a white sticker inside the helmet.

CONSUMER NOTIFICATION

Poster: Attached to this letter is a poster to notify consumers about this voluntary recall. The poster requests customers to **a)** immediately stop using the above listed helmet and **b)** bring the helmet to an official SCOTT dealer in order to have a full refund of the price paid.

The CPSC requires that you display the poster for at least 120 days from the date the recall is announced, in highly visible locations such as at customer information bulletin boards, checkout counters, cash registers, customer service desks and entrances. CPSC plans to announce the voluntary recall to consumers on or about February 16, 2015. In order to avoid confusion, it is important that announcement to the public is coordinated through the CPSC. Therefore, please begin to display these posters on the morning of February 16, 2015 and keep them up through June 20, 2015.

Letter: If you have contact information for consumers who purchased an affected SCOTT Vanish Evo bicycle helmet, we ask that you send them the attached letter to notify them of the recall, or that you provide their contact information to SCOTT USA Inc. so that we can notify them directly.

UNITS RETURNED TO YOUR STORE

If a customer returns a helmet to your store, please check whether the serial number is affected by the voluntary recall. If so, please refund the helmet.

Please note that you must destroy the refunded helmet by cutting the left strap. Please confirm the refund of the helmet on this link www.customerportal.scott-sports.com by inserting the serial number into the data input field and send the letter and the cut left strap back to your national distributor.

SCOTT will provide the refund to you. There is no charge to the consumer to participate in the recall.

UNITS IN YOUR INVENTORY

If you have any of the affected helmets in your inventory, you may not use or sell these helmets. As instructed above, you must cut the left strap and confirm the serial numbers on this link www.customerportal.scott-sports.com
